Walk in Interview for Recruitment of Teaching Faculty, Senior Residents and Tutor/Demonstrator on contract basis at ESIC Medical College & Hospital, Surat (Gujarat).

ESIC Medical College & Hospital, Surat (Gujarat), invites applications from eligible candidates to vacant teaching faculty (i.e. Professor, Associate Professor & Assistant Professor) positions on a contractual basis for a period of 1 years at the outset, with provision of further extension for a period of two years based on satisfactory annual performance subject to maximum tenure of 3-years or 70 years of age or joining of regular faculty whichever is earlier.

Further, Applications are invited from eligible candidates to vacant Senior Resident and Tutor/Demonstrator positions on a contractual basis for an initial period of one year, extendable up to 3 years subject to requirement and satisfactory annual performance or joining of regular incumbent (SR/Tutor) whichever is earlier.

1. These vacancies are provisional and may increase or decrease as per the actual requirement for the teaching & patient care. The Competent Authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving prior notice.

2. Reservation will be as per Government of India guidelines issued from time to time.

3. All Candidates must have up-dated Medical Registration (NMC/ State Medical Council) with all post MBBS/MD/MS Qualification(s)). In case, candidate(s) do not have up-dated registration from Medical Council, they have to show and submit copy of "Applied for document(s)" to concerned authority at the time of interview. In case, these two clauses are not fulfilled, the candidate either may not be interviewed or their results will remain with-held in case the expert committee allows them to appear at the interview. Even after that, if, candidate selected, they must submit updated Medical Registration Certificate before joining.

4. Candidates working in Govt./ Autonomous/ Statutory Institution should preferably have "NOC" at the time of Interview from their Employer. In case of immediate non- availability of the same, copy of

"applied for NOC" and undertaking to be submitted at the time of Document Verification before allowing interview.

5. No private practice is allowed in any capacity after joining as teaching faculty at ESIC Medical College & Hospital Surat (Gujarat).

6. Reservation of Person with Benchmark Disability (PwBD) is as per prevailing guidelines of Government of India. In case candidates in these categories are not available, then the vacancies will be filled from the panel of candidates who attend the interview in view of essential services of the Medical College and for fulfillment of NMC Norms and reservation of PwBD shall be carry forwarded.

7. The candidate appointed under PwBD quota will be adjusted against the vacancy of respective categories of SC/ST/OBC/EWS/General.

8. Retired/Working Professor may also apply for the eligible posts.

(C) Eligibility Criteria:

- **Age Limit as on 29.06.2026:** Not Exceeding 67 Years (except Senior Resident & Tutor/Demonstrator).
- **Age Limit as on 29.06.2026 :** Not Exceeding 45 Years (For Senior Resident & Tutor/Demonstrator), age relaxation as per the prevailing norms of Government of India (GOI).

Note: The maximum tenure of such engagement will be till 70 years of age for teaching faculty whichever is earlier provided other rules & regulations are satisfied.

Note: *As per ESIC Headquarters Office Memorandum No. Z-11012/51/2022-MED-VI dated 08.12.2022, or any subsequent orders issued by the Headquarters Office, eligibility will be determined accordingly. Additionally, non-medical officers, if selected, are not entitled to Non-Practicing Allowance (NPA).

(F) Terms of Contract:

i. The tenure of the contract of faculty will be for 1 year at the outset, with provision of further extension for a period of Two year subject to satisfactory annual performance, willingness and conduct of the candidate and the requirements of this institution. However, the contract will be terminated in the case of (a) appointment/joining of a regular faculty on the same post or (b) attainment of 70 (seventy) years of age; whichever is earlier between (a) and (b).

ii. The Tenure of the contract of Senior Resident and tutor will be for 1 year at the outset, with provision of further extension for a period of Two years subject to satisfactory annual performance, willingness, and conduct of the candidate and the requirements of this Institution. However, the contract will be terminated in the case of (a) appointment/joining of regular incumbent (SR/Tutor) on the same post or (b) attainment of 50 (Fifty) years of age; whichever is earlier between (a) and (b).

iii. The competent authority reserves the right to terminate the services at any time in the public interest, without prior notice or providing any reason. To resign from the position, the teaching faculty/SR/Tutor must submit a one-month advance notice or deposit an amount equivalent to one month's salary. Failure to comply with this requirement will result in the forfeiture of both the one-month salary and the security deposit, and may also lead to the initiation of legal proceedings.

iv. The teaching faculty/SR/Tutor shall not be entitled to claim any service benefits, including Provident Fund (PF), Pension, Gratuity, Medical Allowance, Medical Benefits, Seniority, Promotion, or similar perks.

v. Provision of Hostel accommodation/ Quarters will be made to the extent possible; however, it cannot be claimed as a matter of right. If facility of accommodation is availed, no HRA will be payable and the license fee and any other sum in lieu of HRA will be deducted as per rule.

vi. Any instructions/Circular/policy issued from ESIC Headquarter Office, New Delhi from time to time on the subject will be applicable and binding to him/her.

vii. This being a contractual appointment, any absence from work exceeding 07 (seven) days without prior approval from the competent authority will be considered a voluntary abandonment of the engagement, resulting in automatic termination, forfeiture of both the one-month salary and the security deposit, and may also lead to the initiation of legal proceedings. The teaching faculty must record their attendance both manually and through the

Aadhaar Enabled Biometric Attendance System (AEBAS) on a daily basis during scheduled working days.

viii. Other terms and conditions will be applicable as issued by Competent Authority from time to time.

2. **Document Verification and Interview:** Only candidates whose documents are successfully verified by the Document Verification Committee will be allowed to appear before the Interview Board.
